CONTRACTOR DUES

Contractor Dues are based on your construction work volume (gross revenue) in **northern** Nevada for the prior year. The Dues Schedule shown below include National AGC Services Dues.

Additional Dues (Hourly Dues): Hourly Dues, also called “man-hours,” are additional payments made by contractor members—union or non-union (open shop)—to help cover the cost of the association’s training and safety programs. The dues are calculated based on the total hours worked by your field employees in northern Nevada during a specific period.
