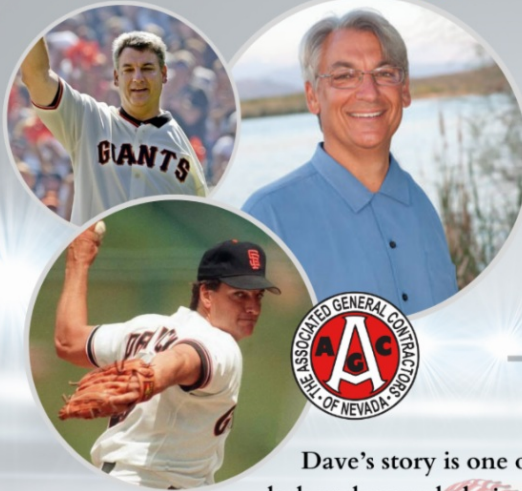

In 1988, at the peak of his career, Dave was diagnosed with cancer in his pitching arm resulting in the removal of half of his deltoid muscle. He was told, short of a miracle, he would never pitch again. Proving the doctors wrong, he came back in 1989 to pitch a 4-3 win for the San Francisco Giants, but sadly his comeback was short-lived as the cancer had returned, forcing him to make the difficult decision to retire from baseball in November of that year.

Rather than let his experience defeat him, Dave has chosen to share his story to inspire others with the optimism and hope he discovered through his own journey.

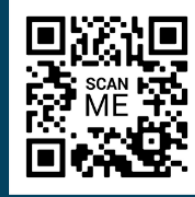

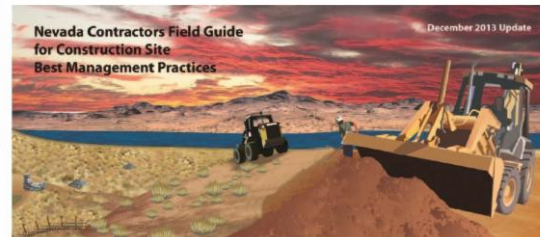

The Apprenticeship Utilization rules have changed!

Effective January 1, 2024, all contractors performing public works construction will need to report their total apprentice hours on an annual basis.

The Labor Commissioner will discuss:

- Requirements of Senate Bill 82

- Penalties for Non-compliance

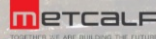
